SUMMARY OF THE EVENTS OF THE SECOND CALL FOR PROPOSALS

16 MAY 2011: ANNOUNCEMENT OF THE CALL

The call was announced on the programme website, in regional and local press, on news websites applicable for the programme area, as well as on the website of the European Commission. The overall indicative amount made available under this call for proposals was 88.143.349,25 euro. The duration of the call was from 16 May until 30 September 2011.

30 JUNE – 01 JULY 2011: PROGRAMME CONFERENCE "TIME FOR CHAMPIONSHIPS OF CROSS-BORDER COOPERATION IN EASTERN EUROPE"

This joint conference took place in Mukachevo in Ukraine and was organised together with the Hungary-Slovakia-Romania-Ukraine ENPI Cross-border Cooperation Programme. The purpose of the conference was to recapitulate development needs of the border areas, to promote these areas and to popularize possibilities of granting offered by cross-border cooperation programmes and other programmes funded by EU.

"We meet in the Ukrainian region Zakarpattia on the last day of the Hungarian Presidency in the EU Council and the first day of the Polish Presidency. When taking the decision to organize the conference here and today, under such title, we wanted to draw your attention to the many things that unite our nations, despite the borders dividing us" - said in his speech Mr. Marceli Niezgoda, opening Undersecretary of State at the Ministry of Regional Development of Poland.



During the conference the second call for proposals was promoted as the greatest undertaking of this type among all CBC programmes financed from the European Neighbourhood and Partnership Instrument. The highlights of the conference included also symbolic taking over of the Presidency in the EU Council by Poland from Hungary, combined with tri-border area study tour and a friendly football match of two teams





The opening speeches of the joint conference were given by Ms. Györgyi Nyikos, Deputy State Secretary at the Ministry of National Development of Hungary and by Mr. Marceli Niezgoda, Undersecretary of State at the Ministry of Regional Development of Poland.







The two ministers opened also the exhibition dedicated to Ferenc Liszt and Fryderyk Chopin.

The second day of the conference was symbolic – participants climbed the tri-border point on the Kremenets Mountain, where Polish consule received the European Union flag from his Hungarian counterpart.

28 JUNE - 21 JULY 2011: FIRST ROUND OF INFORMATION SESSIONS FOR APPLICANTS

During the sessions the Joint Technical Secretariat and its Branch Offices from Lviv and Brest were explaining the application pack requirements and financing opportunities. The following information materials were also distributed: Guidelines for applicants, Application form, Instructions to fill in the application form, Instructions to prepare the brief feasibility study, Handbook on eligibility of costs and List of most common mistakes.

In Poland the first round of information sessions took place in Rzeszów, Krosno, Zamość, Lublin, Chełm, Biała Podlaska, Suwałki, Białystok, Siedlce and Łomża (10 sessions, 587 participants in total).

In Belarus the first round of information sessions took place in Brest, Pinsk, Baranavičy, Hrodna, Lida, Minsk, Maladziečna and Homiel (8 sessions, 372 participants in total).

In Ukraine the first round of information sessions took place in Uzhgorod, Vynohradiv, Lviv, Stryi, Ivano-Frankivsk, Ternopil, Kovel, Lutsk and Rivne (9 sessions, 396 participants in total).

1 JULY – 26 JULY: PROJECT PREPARATION WORKSHOPS (RCBI) IN BELARUS AND UKRAINE

In addition to the JTS trainings, thanks to the support of the Regional Capacity Building Initiative, the applicants from Belarus and Ukraine could also take part in special workshops on project management issues, development of activity based budget, defining objectively verifiable indicators etc. The workshops took place in the capitals of all eligible regions of Belarus (4 trainings, 113 participants in total) and Ukraine (6 trainings, 321 participants in total).

9 AUGUST – 27 AUGUST 2011: SECOND ROUND OF INFORMATION SESSIONS FOR APPLICANTS

The second round was for those who could not participate earlier and for those who wanted to know more about the requirements of the call. Special focus was put on the evaluation process of the applications and on the supporting documents to the application form.

In Poland second round of information sessions took place in Przemyśl, Rzeszów, Białystok, Ostrołęka and Lublin (5 sessions, 270 participants in total).

In Belarus second round of information sessions took place in Brest, Baranavičy, Gomel, Grodno, Slonim and Minsk (6 sessions, 205 participants in total).

30 AUGUST 2011: THE THIRD PARTNER SEARCH FORUM

On 30 August 2011 the third Partner Search Forum was held in Lublin. Potential partners were motivated to register for the event together. Thus still one month before the deadline of submitting their applications, they had a chance to discuss directly planned projects. Nearly 300 representatives attended in the Forum: 121 participants from Ukraine, 98 from Poland and 69 from Belarus. Before the individual meetings started, the conditions of the announced call were

30 SEPTEMBER 2011: DEADLINE OF SUBMISSION OF THE APPLICATIONS

Applications had to be submitted in a sealed envelope by registered mail, private courier service or delivered by applicants at the address of the Joint Technical Secretariat in Warsaw. On 30 September 69 applications were delivered personally. The Joint Technical Secretariat received majority of the applications after 30 September by post or courier (the deadline for the submission of applications had to be evidenced by the date of dispatch, the postmark or the date of the deposit slip).



Applications have been submitted to the JTS mainly by post.

OTHER EVENTS

Training for beneficiaries

On 27-28 September 2011 the Joint Technical Secretariat organised workshops on reporting and promotion requirements for beneficiaries of the first call for proposals.

54 representatives of the 21 approved projects participated in the 2-day workshop. The agenda of the first day started from two presentations led by representatives of the Joint Managing Authority: presentation on financial flows and on specificity of co-financing in public institutions. Then JTS presented in detail activity and financial reporting requirements and schemes for the projects. Finally additional information was provided by Information Officer how to develop communication plans for the projects. The second day agenda was based on practical workshops.

Beneficiaries had an opportunity to exercise filling in both the activity and financial report, including changes in the project implementation. The event took place in Białystok in Poland.



General presentations were attended by the whole group and beneficiaries were split also into two language groups to discuss local law specificities.



OPENING SESSION AND START OF EVALUATION PROCESS

In total 506 applications have been submitted to the Joint Technical Secretariat of the Cross-border Cooperation Programme Poland - Belarus - Ukraine 2007-2013 within the second call for proposals.

Out of the 506 proposals*:

58 applications (11.5%) are trilateral projects, 360 applications (71.1%) are Polish-Ukrainian projects,

88 applications (17.4%) are Polish-Belarusian projects.

The total value of EU co-financing requested within the second call is 796 116 573,36 euro. The total number of partners involved in the projects is 1 515.

The evaluation process starts with the receipt of the proposals by the JTS and ends with the decision of the Joint Monitoring Committee (JMC) to award grants to the selected applicants. The evaluation is divided into two steps:

Step 1 – Opening session and Administrative and eligibility check,

Step 2 – Quality evaluation.

Evaluation Committee (EvC), which is composed of representatives of the three participating countries, holds the responsibility for carrying out and supervising the entire evaluation process. The opening session, lasted from 17 October till 27 October 2011. The JTS registered all applications and prepared a detailed data base of submitted project proposals. Afterwards the administrative and eligibility check started. Applications are verified on the basis of verification grids that are a part of the Guidelines for Applicants (GfA).

The "Opening session and administrative and eligibility check report" will be signed by all EvC members and sent for the final approval of the JMC.

The objective of the quality evaluation is to obtain a ranking list of proposals recommended for funding for each of the priorities of the Programme. The quality of each application form is assessed according to the criteria defined in the GfA. Projects recommended for support are those which received the minimum of scoring envisaged for the whole project as well as for the required sections. No project proposal failing to pass the quality assessment thresholds may be approved for financing. Quality evaluation is finished once the "Quality evaluation report" is signed by all members of the relevant EvC. The final decision is made by the JMC.

Great cultural and tourist potential of Yavoriv and Lubaczów has not been used to the full extent. Limited tourist inflow, lack of promotion, poor state of historical infrastructure impedes tourist development in the region.

Therefore. the project aims at the improvement and the full use of tourist potential of the border region. The objective of the project will be achieved through the creation of tourist information systems for partner cities. renovation of market squares in Yavoriv conducting trainings Lubaczów, providing tourist information and tourist traffic service, promotional events - cross-border

meetings of partner towns and communities, etc.

The project activities aims include: the boost in tourism in the Polish-Ukrainian borderland, the increase in business activity and business contacts in tourism and related sectors, the increase in local communities awareness as far as culture and history of partner towns are concerned and eventually tighter cooperation between border regions and partner towns of Lubaczów and Yavoriv.

Tourism is an important economic branch for the development of the border regions of Poland and Ukraine. The rich cultural potential of Lviv, Rzeszów and Lublin is the basis for tourism development in the region as a whole. However, the number of common initiatives is still too small. Previous contacts of project participants have

proved that insufficient cross-border cooperation

is a significant problem and requires resolute

action.

The main goal of the project is to raise competitiveness of the partner cities in the sphere of tourism. The main assumptions of the project concern the creation of cross-border tourist route on the basis of the existing underground routes in Rzeszów and Lublin and planned underground route in Lviv. The common meetings, seminars and coferences will

become an important project element and will

contribute to its implementation.

Common actions implemented within the project will contribute to cooperation between local authorities in the field of cross-border tourism development. One of the results will be the increase of information level among Poland and Ukraine citizens. One of the most significant factors that limit the regions accessibility for investments and reduce inhabitants' living standard is an obsolete water supply network.



The overall objective of the project is to increase the accessibility of the region of the Lower Bug Estuary for investors, uphold the inhabitants' living standard and improve the region's tourist and economic attractiveness through the improvement of the quality of social and economic infrastructure related to water supply. The specific objectives of the project are implementation of joint water supply

management self-governments in local establishing joint project structures. support of the future investments concerning water supply and the improvement inhabitants' of effective the awareness water management. The core of project is creation of technical documentation for the most prioritized areas of water supply infrastructure.

The result of the project will be the creation of a Common Office for the Management of Water Supply, specially developed technical documentation on water supply for the towns of Hrubieszów in Poland and Volodymyr Volyns'kyi in Ukraine, a number of workshops for the employees of town administrations, extensive information and promotion activities including publications, the Internet web pages as well as two conferences. As the result of the project, both towns will obtain knowledge in the needs for water supply and actual state of investment structure for water supply.

Project reference number: PBU/0156/10

Significant excess of dusts and gases emission, connected with combustion of fuels creates a serious risk to the health of the population and reduces the area interest investments, which negatively impacts the region's development. The aim of the project improve the state natural of environment by decreasing the emission of harmful substances within the district of Lubaczów and Yavoriv region. This aim will be achieved through utilization of renewable energy sources in order to receive heat energy.



The activities planned within the project include installing the solar system in the hospital in Novojavorivsk and purchasing the machines collecting chips form roadsides in the Lubaczów municipality that will be used as biomass in boiler house to heat the School Complex in Oleszyce. This is supposed to lead to the decrease in gas and coal consumption while increasing heat energy received from renewable sources across the Polish-Ukrainian border.

Through decreasing the consumption of non-renewable fuel and increasing the utilization of renewable energy the project should have impact on increasing the energy security, providing the patients of hospital in Novojavorivsk and students of the School Complex in Oleszyce with better accommodation conditions, health improvement of residents of the Yavoriv region and Lubaczów region, improvement of technical infrastructure, increase of institution attractiveness and improvement of staff's work conditions.

The proximity of mines in Tomaszowski poviat to the border areas of Ukraine poses hazard to the natural environment of the bordering regions. Transportation of hazardous substances, lack of effective alarm and early warning systems, as well as outdated equipment reveal the deficiencies in crisis management operations and the need in effective reactions to natural hazards.



Therefore, the project focuses on improving the existing situation by introducing a number of soft and investment measures. The measures envisage the exchange of experience among the firemen in Poland and Ukraine, obtaining specialized equipment for ecological security such as fire trucks, etc.

The result of the action is expected to be the modernization of the technical base of the partner organizations, improvement of the officers' competence level, reinforcement of monitoring system of the state of the natural environment and prevention of hazards of natural environment.

Over the past years the number of natural disasters became cause to a large scale of emergency situations in the Polish-Ukrainian borderland. Geographical location of Lublin Voivodeship, bordering Ukraine and Belarus, shares the risk of spreading the results of chemical, ecological and natural outage and catastrophes with Volyn region.

The aim of the project is the creation of a joint reaction system in crisis situations, natural disasters and technical catastrophes, outages and other circumstances threatening health and

life of the inhabitants of the Lublin and Volyn regions and subsequently improving the safety of the border area.

The activities of the project include carrying out trainings for police officers on crisis response conduct, establishing a safety and rescue cooperation network, purchase and use of specialized equipment and vehicles to conduct rescue operations, etc.

Insufficient rescue capacity of fire service units responsible for responding to natural hazards such as pollution, flood and fire, as well as the lack of permanent institutional and procedural basis for co-operation of Polish and Ukrainian fire service units on implementing a joint hazard management system, results in the problem of insufficiently effective actions for the prevention of natural hazards in the Polish - Ukrainian borderland.

The issue, therefore, calls for the creation of a Polish-Ukrainian platform for co-operation



(including a joint working group) on the implementation of a cross-border natural hazard management system. This would enable Polish and Ukrainian rescue services to effectively analyze and synthesize information on and deal with potential hazards employing methodological guidelines, rescue equipment and joint rescue procedures.

The project implies the creation of the joint management system for cross-border rescue actions, establishing the joint Polish-Ukrainian working group, improving the capacity of rescue services with purchase of new rescue equipment, carrying out trainings for fire-fighters to operate the modern rescue equipment and conducting joint rescue simulation exercises.

Tourism is still an underestimated sector of economy in both Poland and Belarus. Insufficient investment negatively affects the quality of services, promotion and the overall tourism potential of the border regions of Suwałki and Grodno.

The aim of the project is to create a cross-border network of 13 Tourist Information Centres (TIC) in the Poland-Belarus borderland by modernizing 5 existing TICs and establishing 8 new ones – including water TI point on the Lake Wigry/ Czarna Hańcza river.



The project envisages sharing of experience and exchange of best practices among the people working in the tourism sector in Suwałki and Grodno.

A significant focus is placed on the representatives of the tourism sector as a target group, who will benefit from special trainings, workshops and study visits, creation of a tourism Internet communication module, etc. The outcome of the project will be, among others, the establishment of 5 cross-border partnerships functioning in specific fields of agrotourism, tourist information, marketing, active tourism, local authorities and local media.

The problem that is facing the Polish-Belarusian borderland is linked to the lack of specialist medical equipment for breast cancer and colorectal cancer treatment. As such, the Lead Partner established the overall objective of the project as that of establishing a lasting form of co-operation between health maintenance organisations of the Polish-Belarusian borderland in order to increase the detection rate of breast cancer and colorectal cancer and to enhance treatment quality of these diseases.

The project will thus concentrate on the real needs of the target groups and final beneficiaries

of the borderland through the purchase and installation of modern energy-saving medical equipment, creation of patient database, biobank and telepathology and carrying out two research programmes on breast and colorectal cancer.

The achievements of the project are therefore linked to the improvement of medical infrastructure in the borderland area, increasing the level of competence among the medical staff and decrease in breast and colorectal cancer morbidity rate through the incorporation of up-to-date medical equipment to be used on both sides of the border.
